Work with Sibley County Extension Service, Community Health and other agencies on program coordination. Promote BMPS for both urban and rural applications. Encourage wetland restoration and protection through news releases, newsletters one-to-one contacts, public meetings and educational tools. Educate the public on the importance of recycling, yard waste, composting and waste reduction. Provide educational opportunities about adverse effects that point and nonpoint source pollution have on water resources.
